The meeting was called to order at 3:30 p.m. by the Chairman, the Honorable Jim Holland. The Chairman thanked everyone for attending. All CRTAB members introduced themselves. A guorum was present.

Unfinished Business

Mr. Jack Berry-Presentation, Review, Discussion & Recommendations of Draft Proposed Amendments to Taxi Ordinances developed Subcommittee

Mr. Greg Lukanuski, City Attorney's Office, provided an update on the draft proposed amendments to the current taxi ordinances developed by the subcommittee. There was significant feedback from the subcommittee which is noted the packets distributed to attendees. It was noted that while each jurisdiction has the same ordinances they are numbered differently depending on the jurisdiction. Each proposed ordinance was reviewed one by one and was discussed by the industry and Board members prior to the Board voting. The Board voted unanimously to accept each proposed ordinance change with the stipulation that the proposed changes would be sent to each jurisdiction for legal review before any changes are made to the ordinances. The proposed ordinances to be amended are listed on the next page (Comparative Ordinance Table); however, for the purpose of the meeting the Richmond ordinances were used.

Ordinance (Sec. 110-44 in Richmond ordinances)-was a late addition to the ordinance proposed changes. The proposed change is to move the toll charge from this section and move it to the fare section of Sec.110-37 to read, When most direct route requires the payment of a toll the driver shall verify such route and that the passenger agrees to pay the toll charge prior to proceeding.

Proposed ordinance change (Sec. 110-64) request was withdrawn.

Mr. Lukanuski will forward the proposed amendments to the jurisdictions by noon tomorrow. Mr. Berry will follow-up with each jurisdiction. Once each jurisdiction has reviewed the proposed amendments, the jurisdictions will then have to approve the new amendments. There are also public hearings and public input/comment that will be included in the process. Mr. Berry noted that the localities are in communication with each other and will confer with each other in this matter. Mr. Berry noted that this is a process and will not happen overnight although there is a sense of great urgency.

New Business

Ms. Tisdale noted that she is working on an RFP for an entity to serve as the CRTAB staff liaison to include a larger scope of work based on feedback from CRTAB and industry level meetings. The company that was interested in serving in that role has withdrawn from consideration. The RFP is forthcoming.

There is no Customer Service training class in September due to the UCI Bike races. The hotel that hosts the class is booked.

The next meeting is TBD.
